Eligibility- This Law quiz is open for all the students of 5 year law and 3 year LLB course from any of the recognized University/College. **The Quiz will be conducted through two rounds: the Preliminary Round and the Main Round.**

Important Rules and Guidelines for the Law Quiz:

- The quiz will contain a total of 50 questions. It will be conducted through Google Forms.
- There shall be no negative marking.
- The medium of the quiz will be English only.
- The questions will be Multiple Choice Questions (MCQs).
- The participants shall have maximum 20 min to attempt all the questions.
- No request for extra time will be entertained whatsoever. Therefore, the participants are requested to login well in time.
- No complaint regarding the network issues during any stage of the quiz will be entertained.
- **Preliminary Round shall be conducted on 6th Oct, 2020 from 5:00 P.M. to 5:20 P.M.**
- In the case of tie of marks, participant who has submitted earlier/earliest shall be considered.
- Top 8 scorer will progress to the main round.
- The date and time for the Main Round will be announced after the declaration of results of the Preliminary Round. The eight top scorers who qualify for the Main Round will be sent an email with the date, time, and details of the Main Round.
- The Main Round will be a live quiz conducted through video-conferencing via GOOGLE MEET.
- The decision of the quiz master shall be final one.
- The Organizers shall have the right to amend, repeal or introduce any rules as they find appropriate for smooth organizing of the quiz competition.

- Format – MS Word; font – Times New Roman
- Font size – 12 for manuscript, 14 for Headings, 10 for footnotes
- Page numbers – bottom center
- The case comment must be written in English.
- Line Spacing – 1.5 for text and 1.0 for footnotes
- Alignment – Justified and layout must be A4 size
- Margin – One inch each side
- The citation methodology to be followed is Harvard Bluebook (19th Edition).
- Any kind of plagiarism shall not be allowed. It will be checked on plagiarism check software before being considered.
- Participating in the event means that you agree to abide by all the rules of the competition.
- Further flow of the content must be logical, conveyed with utmost clarity and grammatically correct.

Rules

4. The participant should be in formal attire.
5. The voice of the participant should be clear and audible during whole of the video.

Judgment Criteria

1. You shall be marked on the basis of content, body language, intonations, confidence and time management.
2. Deviation from the topic shall lead to negative marking.
