Elimination of Violence against Women: Issues and Solutions

Violence against women and girls is a major human rights issue. Violence against women occurs throughout the life cycle pre-birth, infancy, childhood, adolescence, adulthood to old age¹. Its effect goes from immediate to long haul numerous physical, sexual, and mental, emotional, ramifications for women and girls, including death. It adversely influences women's overall prosperity and keeps them from completely participating in society. The violence exists in the form of assault, battery, sexual harassment, outraging the modesty of a woman, cruelty, harassment, dowry death, honour killing, trafficking, acid attacks, genital mutilation, forced prostitution, domestic violence, rape, war crimes, etc. Violence has negative ramifications for women as well as their families, the community, and the nation at large. It has colossal expenses, from more noteworthy medical services and legal costs.

Most of the countries in the world have enacted laws against domestic violence, rape, and other forms of violence. Difficulties remain anyway in implementing these laws. Insufficient is done to forestall savagery, and when it happens, it often goes unpunished. The delay in the administration of justice does not have the impact of deterrence. Despite the establishment of special courts it takes years to decide the cases, Nirbhaya case is a classic example of this.

The fear of stigma, the family and social pressures, fear of losing the job, the unfriendly administrative and legal procedures also prevents women from reporting the cases or taking them to any logical conclusions. Though social media

has also helped the women to raise voice against different kinds of violence committed against the in-form #MeToo, #TimesUp, #Niunamenos, #NotOneMore, #BalanceTonPorc. The unheard and unreported incidents of abuse and violence came to the picture though many of them did not help in securing justice to the victim due to delay in bringing these cases to highlight. There is no respite in violence against women, incidents of trafficking, sexual abuse, rape have been continuously increasing in several countries including India.

On 25 November 1960, the Mirabal sisters (PatriaMirabal, Minerva Mirabal and Maria Teresa Mirabal) were brutally assassinated because of their identity as women and activists. Their only offense was fighting for their rights against the Dominican dictator, Rafael Trujillo (1930-1961). The assassination of the Mirabal sisters turned into a symbol of feminist resistance. In 1999, in the sisters' honor, the United Nations General Assembly designated 25 November the International Day for the Elimination of Violence against Women. International agreements such as the Convention on the Elimination All Forms of Discrimination against Women (CEDAW), in particular through General Recommendations 12 and 19 and the 1993 UN Declaration on the Elimination of Violence against Women, uphold the right of women to live free from violence.

University Institute of Legal Studies is organising a one-day National online seminar for students to sensitise young minds about the need for the elimination of violence against women, to deliberate on issues related to it, and find solutions that women are not subjected to abuse and violence in any form.
