The Competition would be conducted on an online platform, details of which would be provided post registration. The dates of the competition are 20 to 22 November '20.

Registration Details:

- ✓ The Competition is open to the Students enrolled in U.G. & P.G. Courses.
- ✓ Institutional and Cross Institutional teams can be registered.
- ✓ There is a cap of overall 32 teams with not more than 8 cross-institutional teams.
- ✓ Teams are required to follow the n+1 rule.

Participants are requested to register by filling the google form before the deadline and attach the receipt of payment of registration fee in the registration form.
