## Rules

1. That the competition is open for Undergraduate law students only.
2. There shall be only 2 teams from one participant college
3. The team shall comprise of only 2 speakers one for favor and other against the topic.
4. That there shall be 4 rounds of debate competition :Prelims , quater finals,Semi Finals and finals
5. The whole team shall qualify for the next round on the basis of the sum total of the score of both participants from one team.
6. That there shall be different topics for each round in the debate competition.
7. The participating college shall not be allowed to change participants for different rounds or interchange participants of different teams nor the participants will be allowed to change their side from for to against in different rounds and vice-versa .
8. The registration form is required to be sent by approval of the college coordinator by writing the name of faculty and contact details.
9. The topic of debate competition are :

Prelims: The Farmers bill is detrimental to the interests of farmers.

Quarters: One nation one election is not necessary for India.

Semis: NRC is not necessary for India.

Finals: The state's regulation of religious rights should be minimal.

10. The time limit for each speaker will be: for prelims - 4 minutes, for Quarter finals 5 minutes, for Semis- 5 minutes, for finals 7 minutes.

11. That each speaker after he/she has spoken shall be questioned by the judges on the speech made for a total time of 2 minutes in prelims, 3 minutes in quarters, 3 minutes in semis and 5 minutes in finals.

12. That the dress code of formals is compulsory for each participant, violation of which will lead to disqualification of the team.

13. That each team is required to pay a sum of 200 INR for participation

14. That the English is the desired mode of the competition.

15. That the duly filled registration form needs to be sent on email address [MLClegaledebate@gmail.com](mailto:MLClegaledebate@gmail.com) by 25 December 2020 along with payment via Google pay on

18.The registration fee is non transferable or refundable.
