DETAILS OF THE EVENT

INTER-UNIVERSITY CLIENT COUNSELLING COMPETITION, 2025

Eligibility

Students enrolled in a law program and pursuing full-time five-year or three-year undergraduate law courses in any University/ College/ Department are eligible to apply for registration of their team in Inter-University Client Counselling Competition, 2025.

Team Composition

- Participants must make a team of 2 students in order to participate (Counsel 1 and Counsel 2).
- Only one team from each institution is allowed to participate in the competition. If two teams of the same institution apply, the first registered team will be selected for participation.

Registration & Important Dates

- Registration fee shall be following –
 Early Bird Offer (Valid till 10th Feb) Rs. 1200/- team
 Regular fee after 10th Feb Rs. 1500/- team
- Participants interested can register on the below mentioned link and the acknowledgement of the payment must be submitted along with the online registration form-

- Once a team's registration is done, a 'team code' shall be assigned to the team.
- Dates –

Last date for Early Bird Registration– 10th February, 2025 Last date of Registration – 20th February, 2025

Rules & Regulations

- The official language of the competition shall be English.
- All submission made to and/or before the judges shall be in English.
- **Dress Code**: Participants are strictly required to adhere to the following dress code during the competition –

Male - White Salwar and Kurta or White Shirt and Black Pant, Black Coat, and Black Shoes.

Female - White Shirt, Black Trousers, Black Tie, Black Coat, and Black Shoes

- Use of Advocate's Gowns, Bands and Robes is strictly prohibited.
- No accommodation/TA,DA will be provided by the university.
- The decision of the judges/panel and the organization committee shall be considered final and non- debatable in any dispute.

Grounds for Disqualification

Any team or participant will be disqualified for any kind of misconduct on the part of any team member(s) or coach during the Competition. Misconduct includes -

- Disclosure of identity to other Participants during the course of the round(s) or to any judge. The participants should only use the Team Codes provided by the college.
- Any attempt made by Participant(s) to obtain problem particulars with regard to the Client-Consultation Session.
- Any attempt made by Participant(s) to contact any judge before or during the Competition, unless specifically invited to do so by that particular judge(s).
- Any attempt made by Participant(s) to speak any kind of controversial, sex, caste, race, gender, foul language, anti-national, before or during the Competition.

Format of the Competition

The client counselling competition will be conducted over two days in hybrid mode: -

- ✤ 27th February, 2025 (Online) → Inauguration, Preliminary Round &
 - Quarter-Final Round (Conditional min 16 teams)
- ✤ 19th March, 2025 (Offline) → Semi-Final, Final Round &Valedictory

The competition consists of mainly three rounds, with a possible additional round depending on the number of participating teams.

Preliminary Round:

- All registered team will participate in this round online on 27th February, 2025.
- The session will include 20 minutes for consultation or interview period, followed by 10 minutes for post-consultation or post-interview period.
- Qualification –

If Quarter-Finals are not held: The top four teams will directly qualify for the Semi-Finals.

If Quarter-Finals are held: The top eight teams will qualify for Quarter-Finals.

Quarter-Final Round: (Conditional)

- This round will only take place if the number of participating teams exceeds 16.
- This session will include 25 minutes for consultation or interview period, followed by 10 minutes for post-consultation or post-interview period.
- Qualification The top four teams will qualify for Semi-Final Round.

Semi-Final Round:

- Semi-Finals will be conducted offline on 19th March, 2025.
- This session will include 30 minutes for consultation or interview period, followed by 10 minutes for post-consultation or post-interview period.
- Qualification The top two teams will proceed to the Final Round.

Final Round:

- Finals will be conducted offline on 19th March, 2025.
- This session will include 40 minutes for consultation or interview period, followed by 10 minutes for post-consultation or post-interview period.

No extra time will be provided in these rounds. If any participant exceeds the time limit, he/she will be muted by the room coordinator.

Themes

The competition will focus on following areas/spectrum of laws:

- Contract Law
- Family Law
- Criminal Laws
- Participants are advised to prepare thoroughly in these areas, as the client scenarios and questions will revolve around them.
- The problem of client counselling shall be provided 72 hours before the competition and the client will be provided on the spot.
- Separate problem shall be shared for semi-final round and final round.
